The nominee should:

- Be currently employed in the field of Child Intervention within the last year (year of nomination)
- Have worked a minimum of two (2) years in Child Intervention
- Be someone who works directly with foster and kinship caregivers, but not limited to
- Project a positive image of social work as well as foster and kinship care
- Encourage and be a support to foster and kinship caregivers
- Be an advocate for foster and kinship caregivers as well as children and youth
- Have not received this award in the past

Who Can Submit a Nomination and how are they submitted?

- Nominations will be accepted from any interested individual.
- Nominations must be submitted on the AFKA nomination forms.

How many awards will be given out?

One nominee will be selected from each zone, per category. The zones include: South Zone, Calgary Zone, Central Zone, Edmonton Zone, North Zone and Metis Settlements.

When will the awards will be given out?

The date and location of the presentation of the AFKA 2021 Awards is to be determined, however, they will likely be presented during Alberta's Foster and Kinship Caregiver Appreciation Month in October. More information will be shared via email and our website when it is available.
