CHIEF EXECUTIVE OFFICER'S REPORT

This last quarter has had some changes in the Ministry of Children and Family Services, the AFKA, and for caregivers across our province. Alberta's Ministry of Children and Family Services has a new Minister, the Honourable Searle Turton. I would like to take this opportunity to thank the outgoing Minister, the Honourable Mickey Amery, for the interest and commitment he had shown within his role to do what he could to listen to foster parents in Alberta, to work with the AFKA to ensure he had a good understanding of the challenges caregivers are facing, and to try to work toward the implementation of changes that would support some of the challenges. I now welcome Minister Turton into this role and look forward to building a collaborative, informed relationship. Minister Turton and myself had a virtual meeting to become acquainted with one another and to highlight items of importance to the AFKA and Alberta's caregivers, those we wish to discuss further and see how they can be addressed. An in-person meeting has been established with Minister Turton, myself, and the AFKA President at the end of July 2023. We will be raising the concerns we have been working at trying to address, as well as sharing with him the initiatives of our association and how they can support both Alberta caregivers and Ministry.

We continue to be involved in the provincial Caregiver Recognition Working Group, where a solid plan of various ways to recognize caregivers is shared. This is a dedicated group of individuals from each region who can help implement recommendations and is also a place for our team to bring forward ideas and concerns we may have with current recognition practice. This group helps hold regions accountable and provides them a space to be creative, hear the AFKA concerns with current recognition practice, and to learn from one another. The AFKA team is also working on developing ways we can recognize caregivers for the work they do, to highlight the world of foster and kinship care, and to celebrate those doing great things; these are ever evolving and we hope to be doing more in the future.

The AFKA is working on building relationships with DFNAs throughout Alberta, as well as with those who have come into their own coordination agreement with the Federal Government through Bill C-92. Once those nations have this coordination agreement in place, they are then referred to as Indigenous Governing Bodies (IGBs); therefore, if you hear that term being used, those are the nations being referred to. IGBs, through their own coordination agreements, have complete responsibility for their own child intervention practice through their own laws that guide their work with policy and practice. We are working at developing a list of contacts that will be important to have in the future should a caregiver sign an agreement to provide care through and IGB. If you are in this position and need someone to talk to, please do not hesitate to reach out to myself at the office (780-701-4090).

Part of our relationship building with DFNAs, agencies, and IGBs is participating in collaboration and learning days together; the most recent was called "Walking the Children Home – Part 1

and 2". The AFKA has made significant connections with several individuals and are proud that we are walking together in a collaborative way to develop a common understanding of those impacted by these transitions, as well as to develop a common language to describe what is happening within these changes and transitions as a result of Bill C-92.

The AFKA was invited to speak to many Alberta Public School Board Trustees at their spring symposium in Calgary. These trustees are members of the Public School Board Association of Alberta (PSBAA), and were able to listen and be engaged in conversation and consideration of action regarding doing more for children and youth in care. This presentation was very well received and left many in the room with a new or renewed awareness of the world of children and youth in care, as well as those who are caring for them. I do hope that you start to see more engagement and understanding at the school district level; this may be a slow process, however we will continue to work on these conversations as they are important in creating a real team who understands these vulnerable children and youth, and their families.

Other community connections we have made and are nurturing, or continue to nurture, includes the University of Calgary's Social Work Program (Edmonton Campus), Shiloh Youth Camp, Fort Edmonton Park, the Injury Prevention Centre, Little Warriors, and Alberta Health Services. We will continue to reach out to other community organizations or businesses as we are able to do so.

The AFKA Board was involved in a "Strategic Sprint", to follow-up from the strategic planning done in the fall of 2022. This was important to the AFKA, as there was a need to narrow the focus of strategic planning goals for the next 12-18 months. The results of this activity will see some of our goals evolve over time.

We have hired 2 more part-time employees throughout the province to support caregivers in their regions. We now have a part-time employee in each region to support caregivers through assessment of care concerns/allegations, and dispute resolution. To reach these individuals, please contact the office directly to be matched with the appropriate Caregiver Support Team (CST) member.

We have a new part-time Administrative Assistant to support the work being done in the office; welcome to Serena Widynowski. As well, I would also like to welcome Tara Shearer, our new full-time Finance Officer. We are so fortunate to have the skills and passion these two ladies bring to our team.

We are near completion in the development of our new CRM (Customer Relationship Management) database. We are excited for this new system of supporting and tracking memberships. In addition to this, we are developing a member portal through our website where information can be shared and received with members more effectively. The member portal will hopefully be in use by the end of this calendar year.

The AFKA was given an opportunity to review a draft plan being developed for Special Rates assessments, policies, and practice. It does appear the Ministry is working very hard to create a system that is fair and consistent for practice throughout the province. We have no timeline for when this will be officially put into practice, however will share more information as we receive it.

Our Caregiver Support Team (CST) is regularly meeting the regional Placement Concerns Response teams (PCR) throughout the province. PCR teams are those who do the work of assessing homes who are highlighted with a "care concern". Our Caregiver Support Team supports these families through these experiences and can collect valuable information to share about the practice (successes and challenges). During these regular meetings between the AFKA CST and PCR, the teams come together to review practice and express concerns that may exist within that region.

The AFKA's Caregiver Support Team (CST) continues to host their "Caregivers Matter Chat" every month. Please visit our website to sign up for a time that works for you! We are working on increasing the amount of these chats, as they've been proving to be a valuable place for caregivers to go and connect with a community of people with similar experiences and challenges.

The AFKA was able to award 4 bursaries of \$750 each, for post-secondary education financial support. We are certain those who received the bursaries are going to do great things for others, ranging from children to adults, and supporting a way to better the lives of those they impact.

The AFKA Awards nominations are now closed. There was an update to the titles of the awards, specifically those in the category of staff within Children and Family Services, as we wanted them to be more reflective of the work being done and those we are recognizing for a job well done. Although submissions are closed for this year, please take some time to review our website for the awards that are open for recognition and truly consider recognizing someone next June!

With regards to awards, foster and kinship caregivers in Alberta are recognized for their time providing care through the receipt of a Citation Award. These are given out for every 5-year increment; if you believe you are to be recognized, please let your support worker know to ensure you are included on the lists the region sends to the Ministry in the month of July.

The 2nd annual AFKA Art Contest was a success, with many wonderful submissions received. The committee that reviews these submissions are a group of individuals outside of the AFKA. They chose 4 pieces of art (one from each age category), which will be used in notecards to be given to caregivers by CFS staff. The artwork will also be displayed in the AFKA office and used for promotional activities. Please watch for the 3rd annual AFKA Art Contest to open early next year and share the talent of those children and youth in your home!

The planning is well underway for the 49th Annual AFKA Conference in Jasper, AB. There are some exciting changes to the layout of our upcoming conference to watch for! Registration will open mid-late August, so keep your eyes open for the email to come with more information. If you are not on our email distribution list, please visit our website to be added www.afkaonline.ca.

The AFKA sends out surveys at various times throughout the year, for various reasons. If you receive a survey from us, please take a couple minutes to complete it as it provides us with valuable information regarding support, planning, and advocating to the Ministry for additional supports. Thank you for this consideration!

I would like to close by giving my sincerest thanks to the greatest team I could have. The staff we have working for the AFKA are so dedicated to and passionate about the work of the AFKA and doing the best we can to support the caregivers in ways that are needed. Thank you, also, to our Board of Directors, who also are extremely committed to doing what they can to help the AFKA succeed in supporting foster and kinship families in Alberta. I would also like to give a thank you to the external stakeholders and organizations who consider the AFKA a partner and do what they can to support our association in supporting our members in ways that are needed.

I have heard from one foster parent that she has been granted guardianship of her Indigenous foster son whom she has parented since he was a baby. She is an Indigenous foster parent and gained guardianship after a lengthy process and many court dates.

Still hearing about barriers to getting supports for behavioral issues of some children in care, and supports for mental health. Hearing about problems with reimbursements on expenses. Still hearing about cost of food and inflation of everything, but no increase to foster maintenance.

I would like to become the Metis Director for the AFKA Board of Directors. I have ideas to help bridge the MNA to the Board, as well as help advise on how the AFKA can fill in services areas not covered by the MNA under Bill C92.
