It has been a very busy few months in the AFKA office supporting the evolution of our programs and supports for caregivers, supporting caregivers, advocating, collaborating with partners, as well as supporting transitions in programming and new staff within our team.

We continue to provide information to our membership, as received and needed, which includes updates regarding ministry policies and practice, support programming through the AFKA, and additional news and activities of relevance to the Children's Services foster, kinship, and adoptive communities. Through the months of January-March 2023, we have expanded our caregiver support team to the best of our ability to include a team member within each region of the province. As funding and capacity allows, we hope to expand those numbers of caregiver support team members, specifically in the regions where it is needed the most.

The AFKA team is continuously working to have collaborative conversations with important stakeholders across the province as a way to expand supportive services and relationships for the betterment of everyone involved in supporting children/youth in care. As always there are changes, at times beneficial and others challenging, that we will continue to have conversations about with these stakeholders; it is important for everyone involved in the sensitive world of the children/youth in care to time to understand one other and to work in a transparent, collaborative environment. Through some of these relationships, the opportunities for training for both AFKA team members and the AFKA membership is expanding. We share these opportunities through our member email distribution list and media platforms (i.e. Facebook, AFKA website). These interactive sessions are for all Children's Services foster, kinship, and adoptive caregivers to come together and chat in a safe space. The AFKA has worked with our insurance brokers, LloydSadd, to develop a group home and auto insurance program tailored specifically for our caregiver members! We are very excited about this, as we know there are some members who struggle to get insurance for these items

The AFKA Art Contest 2023 has been open for submissions since February 2023. This is a great opportunity to engage in some fun with your kids, as well as to showcase their talents! The winners of our art contest receive a \$100 gift card, and their artwork is printed on notecards for use by staff within Children's Services throughout the year. The AFKA Bursary, designed to help in continuing education, is now open for applications. The AFKA hosted our first ever Indigenous Cultural Event in collaboration with Fort Edmonton Park on March 25, 2023. Although the AFKA has had many years of providing these type of opportunities at the previously owned Brownell Children's Retreat, this was our first attempt to collaborate with external stakeholders to help deliver training opportunities of this scale. It was a very positive (and snowy) day, with families engaging in teachings, games, and fun together. We have taken some learning of our own from this event to help us plan the next one to be even better. We are looking at other venues across the province to provide similar training opportunities and will share these with the membership as they are arranged. Please let us know if there are any venues you are aware of and could support our connection with.

We are beginning the planning for our 49th Annual Training Conference and Awards Banquet! It will be held again this year in Jasper, Alberta from October 26-29, 2023. We are making some changes to the layout of our training, and working to incorporate feedback into the sessions and time spent throughout the weekend. We are excited to share more information with you, with a goal to have our registration open in August 2023.

January 2023 brought news to Children's Services caregivers of inclusion in the Alberta Affordability Program being rolled out for Alberta families. As an outcome of the advocacy done to the Ministry last year to recognize the increase in the cost of living for Alberta's foster, kinship, and adoptive families, the affordability payments were recognized as important

additional support for caregivers with children in their care through the Government of Alberta. The inclusion of these families in the affordability program was a step forward in recognizing the need to help offset, even temporarily, the increased costs of providing care. Conversations will continue with the Ministry regarding the persistent need for an increase to basic maintenance.

In February 2023, there was a round table discussion organized with the Minister of Children's Services, the Honourable Mickey Amery. This round table was a time for the AFKA and local/district association presidents to meet with the Minister directly, sharing the concerns and themes brought forward by caregivers across the province with specifics to each region. It was a very productive conversation, with the Minister actively acknowledging the concerns brought forward and trying to find a way to have a deeper understanding as to why some of the challenges exist. The presidents were asked to provide the Minister with some further examples, which was done. The AFKA has reached out to the Minister and his team to arrange a meeting for follow-up, as well as to establish a time to discuss the challenges that exist for kinship caregivers. There have been a couple meetings established, however for uncertain reasons the meetings have been rescheduled and/or postponed. As soon as the AFKA has any further information from the Minister on how the challenges have been, or will be, addressed, we will share that out to the membership. The AFKA and local/district association presidents would like to extend a heartfelt thank you to all of you who have shared your stories. We understand the strength it takes for some of you to come forward, as well as the importance of sharing these stories to help create change.

To be as informed as possible as a Children's Services foster/kinship/adoptive caregiver, it's important for you to be active as much as possible at the regional level, as well as provincially through the AFKA. If you are active through the regional level, you provide information to the local/district associations they can use to bring issues forward at the regional level and through the AFKA's Board of Directors to the provincial level for advocacy. The more active members are, the more effective voices will be heard. Our popular Fireside chats are back up and running; the first for 2023 was on March 16th and provided valuable education on bill C-92 and how it impacts children in care.

We are excited to announce the expansion of our community partnership program to include Heritage Park. Members of the CFPA will now have access to Heritage Park passes at no cost. DIRECTOR – CENTRAL REGION

Hello from Central Region! It has been a quiet couple of months, I think the highlight for Central Region, as it is for most regions was the round table with Minister Mickey Amery which occurred in February. As a result of that meeting, numerous foster parents provided me with emails/information to pass on to the ministry about the challenges they are facing.

Red Deer Caregiver Association continues to meet monthly to network and support caregivers. There is a core group of foster and kinship families who attend, and as always, they are looking for ways to increase attendance.

The Central Region Caregiver Council meets once a month via zoom. Attendance is typically just board members and occasional presidents of the regional associations. Despite lots of notice and sharing of the meeting attendance continues to be low.

I did ask on the Central Region Facebook page for any news/successes and challenges. There were very limited responses, however 3 foster parents did reach out to share.

One Central Region foster parent shared that a success for her was the get togethers the Red Deer region has been able to put on for foster parents. Specifically referencing an activity that was done in the fall at the local corn maze. Another success is the in-person meetings that have been occurring within the red deer region.

Challenges noted by caregivers within central region:

- Allegations and negative information are discussed by workers with each other and supervisors but not bringing it to the foster parent's attention in a timely manner. Foster parents only finding out about issues at licensing, this has left foster parents feeling hurt, surprised, and frustrated. If information is worth reporting to workers or supervisors, then it should be immediately addressed and not brought up months later at licensing.
- Foster parents being frustrated or getting into trouble for providing information and reaching out to a child's lawyer through the OCYA (LRCY) it appears to be a grey area, however the foster parent is being told by the OCYA that the lawyer works for the child and foster parents are free to contact the child's lawyer and provide information. Foster parents being then reprimanded by caseworkers and being told they are not able to share information with the lawyer.
- Single foster parent told they should have a better support network when a child in their care ended up getting sick. The foster parent reached out to the worker requesting assistance with care for the child so the foster parent could attend an important meeting. The foster parent made to feel inadequate and unappreciated.

- Overloading some foster homes while other homes remain empty. Very frustrating for foster parents to see and understand why this is happening.
- Level 1 foster parents not being compensated appropriately when level 2 children are placed in their homes. If a level 1 home is parenting a level 2 child they should be compensated as a level 2 home.
- Kids being removed from a placement they have had for years with 2 days notice.
- Lack of expediency when it comes to permanency for children. Workers drag it out for years saying it is not a priority for them.
- Ministry directing people who inquire about adoption to foster care, but then the
 ministry does not support foster parents to adopt their long-term placements, sets
 everyone up for failure.
- High number of long-term foster parents quitting or no longer taking placements while they wait for their current kiddos to age out of permanency as they intend to quit fostering at that time.

My goal as Central regions Board of Director is to continue making connections with area caregivers. I would like to find a way that allows foster parents the ability to feel safe in forwarding their concerns and successes and advocating for foster parents.

The North continues to be a busy place! On February 17, 2023, Melissa from the AFKA, AFKA reps and presidents met with the ministry as a collective voice, province wide concerns were brought forward. The ministry is listening and committed to change. It's very important each and everyone's voice is heard continue to share your concerns.

Northern Alberta Caregivers Committee (NACC) met January 24, 2023, in Slave Lake. Struggles with transitioning and structure changes are an ongoing agenda item. NACC met via Zoom February 21, 2023. Items discussed were CMI'S, Signs of Safety, recruitment, long term foster care, transitions & growth series. An in person gathering of staff and caregivers took place in St Paul March 2, 2023, for Operational Planning. This is the first-year caregivers were included.

Operational Planning is a living document which sets the tone between the ministry, the province, and the region for a three-year period. The long-term goal will fuel future business discussions.

A recruitment campaign began February 1, 2023.

A letter from the minister media release focusing on a wide area of needs and posters with current pictures have gone out the target is 200 new homes.

The surveys that were sent out to both foster and kinship homes indicate similar feelings across the province, caregivers want to feel respected, appreciated and a part of the team. Unfortunately, this is not happening, the survey will once again be sent out stressing the importance of voicing your concerns, each survey will be kept anonymous.

Fall training events for the North are underway! The central group will meet with Theresa Ouellette and Shaun Miller March 15, 2023, for planning. More information will follow as plans are finalized.

The Caregiver Connection meeting have been rescheduled, the first Tuesday of every month at 1:00 pm and the second Tuesday of every month at 8:00 pm. Come join us! This is a wonderful opportunity for foster and kinship caregivers in the North Region to connect in a safe setting to share successes and challenges. A zoom link will be sent out prior to meetings. Mark your calendars! The Caregiver Connection group is hosting a camping weekend June 2-4, 2023, in Rochester, more information and registration will come out soon!
